Grants to Date

January 1-December 31, 2009: \$5,902


- \$1300 for five *Alphasmart NEO* portable word processing tools for the **middle school**
- \$350 for a digital photography project at the **Trumansburg Community Nursery School**
- \$500 for the purchase of a disc repair machine for the **Ulysses Philomathic Library**
- \$125 for MP3 players and special education access to audio books in the **high school**
- \$400 for a solar powered water pump at the **elementary school's Kids' Garden** (managed by **Black Locust Initiative**)
- \$1000 for a 3 day Canadian culture program for **5th-6th grade** students
- \$277 for "eat well, live well" - a Wegmans field trip introducing **4th grade** students to healthy living habits
- \$750 for "more peas, please," a **kindergarten** garden project that teaches science, math, nutrition and well-being
- \$1200 (restricted) for **middle and high school** biology student access to the Cayuga Lake Floating Classroom

January 1-December 31, 2008: \$7,445


- \$500 for sensory processing disorder materials for the **elementary school**, helping teachers detect and prevent more serious behavioral problems
- \$2150 for international health, prevention and wellness speaker Dan Davis for a **high school** student assembly and parent program
- \$250 (restricted) Street Survival School for **high school** students at Watkins Glen International Speedway
- \$1300 for a Dell notebook storage cart for **3rd grade** classrooms
- \$775 for ten *Playaway Audio Books* for the *Curiosity Center* and other resources in the **elementary school** library
- \$900 for the *Brain Gym* program and *Brain Gym 101* teacher training for the **elementary school**
- \$570 for ten pan-balance scales, four microscopes and five sets of weights to provide hands on math and science activities for **2nd grade** students
- \$1000 for four *Alphasmart NEO* portable word processing tools for the **middle school**

January 1-December 31, 2007: \$2,700


- \$200 for sixty copies of the *Wall Street Journal* per month to complement a **high school** seminar series on financial planning co-sponsored by the Foundation
- \$1000 (restricted) toward the purchase of sheet music, private music lessons, school owned instrument repair, small hand percussion and/or African drums, and travel fees for **high school** students and their teachers to attend All-State or All-Eastern band/choral events
- \$700 for the purchase of a document camera for the **middle school**
- \$350 (restricted) Street Survival School for **high school** students at Watkins Glen International Speedway
- \$450 for the **Trumansburg Committee for Teen Driver Safety's** purchase of books and DVD's for a **high school** Driver Safety Library
